Transition Updates

New ABP Portal

On June 3, 2022, the Illinois Power Agency announced <u>portal offerings</u> that will be available to Approved Vendors and Designees of the Adjustable Block Program during the transition to the new Program Administrator, Energy Solutions. This temporary portal, which will be in place on July 1st, will support Approved Vendors and Designees in critical functions, while a new, enhanced ABP portal is developed to drive the program's growth in its vital second phase, as envisioned by the Climate and Equitable Jobs Act. Along with the temporary portal, supplemental support channels will be available from Energy Solutions to allow Approved Vendors and Designees to complete other important processes and activities.

Information on additional availability of CSV and API Disclosure From generation options will be released next week. The following table outlines the planned support channels for an array of key program functions during the transition phase:

• ICC Submissions During Transition & Application Pause Period

The last Illinois Commerce Commission meeting at which the current Program Administrator will submit projects will be **July 7, 2022**. The date of the first ICC meeting at which Energy Solutions will submit projects will be forthcoming.

Please be aware that the Adjustable Block Program is going through a transition of Program Administrators, and as part of the transition, the IPA is placing a temporary application pause on all ABP
