- Need Info clean-up project in the coming weeks



# Part II App Helpful Tips

- If the property owner and the customer on the CoC are different, AV should enter a note describing the relationship in the comment section
- Photograph of All Installed Modules
  - We need to be able to count the number of modules
  - Try not to cut off modules in the photo
  - An aerial shot of the house with all installed modules works best
  - Please submit multiple photos of each section if all modules can't be in 1 photo
- Photograph of Meter
  - Should be of the Meter itself
  - If a screenshot is be used, make sure it comes from the meter portal and not inverter portal
  - If it is an expansion app, please provide proof of separate metering with your application as an optional upload






# **Schedule for Remainder of 2022**

- Community Solar Applications
  - Part of the Application Processing team is currently focused on reviewing the TCS and CDCS applications received for the new Program Year
  - These projects need to move through the program as a group due to the scoring element
  - Expected to last into Q1, 2023
- Distributed Generation Applications
  - New Part I DG apps received in the portal on or after September 1, 2022
  - New Part II DG apps received in the portal on or after December 15, 2022
  - There will be a continued focus on responding to and processing Need Info responses








### **Portal Technical Walk-through**





#### **Portal Walkthrough**






### **Data Migration Update to Support Part II Applications**
