• Contact Information

The "energy supplier" should not be a required field for general contact information because that information is unnecessary to implement community solar products. If this information is required in the optional "Alternative Retail Electric Supplier" section, then limit the requirement to identify the energy supplier to that section. Customers unwilling to provide their energy supplier information (or even unaware) to obtain a general community solar subscription would be blocked in the enrollment process.

Authorization to Manage Your Utility Account and Bill Payment

Authorization to modify energy supply should not be included within the Community Solar Disclosure form. This section should not include requirements or authorizations related to agency with respect to "your energy supplier". Most community solar products do not require any agency related to the energy supplier. Estimate Your Savings

Does the Disclosure tool automatically populate the Price to Compare (PTC)? If so, what is the PTC source and how are the seasonal PTC rates of the utilities applied in this calculation?

• Rate and Payment Information

We believe our community solar product is covered under the drop-down option "Payment equal to x% of community solar credits on your utility bill"; however, given timing of the utility billing process and potential billing issues which could cover multiple community solar bill credit periods, there could be some confusion. For example, the "Frequency of payments and start date" information is expected to be monthly and start date will be determined when the utility actually applies the first allocated credits. We can only estimate when those utility actions will occur. It may be more meaningful to state the billing for the credits will follow the application of the credits on the Utility Invoice and the timing is determined by your Utility tariff billing sections.

• Total Estimated Utility Bill Credits and Savings

Does this entire section or only parts thereof appear with the "Variable Rate" product option scenario?

The below statement may cause confusion for customers with a subscription "Payment equal to x% of the community solar credits on your utility bill" since they are in effect guaranteed savings regardless of the size, number of credits or month of year:

To maximize your savings, it is important that your subscription size matches your usage over the course of the year. If your subscription is sized too large, it is possible for you to purchase more bill credits that you can use. Keep in mind that the solar project will generate more electricity in the summer months than in the winter months.
