Program News

• Reminder: Traditional Community Solar Score Appeal Deadline - March 24, 2023

In accordance with the <u>TCS scoring guidelines</u>, the Program Administrator has scored all TCS projects submitted on November 1, 2022 that are Part I verified. These scores will be used to determine which projects will be selected for a REC contract once random selection (if needed) takes place and the 20% developer cap is applied. The scores and a full announcement regarding the scoring process were posted on the Program website on the <u>Solar Project Categories page</u> under the Traditional Community Solar sub-section.

An Approved Vendor may appeal decisions made by the Program Administrator on the scoring of their projects. An Approved Vendor has two weeks from March 10, 2023 to file an appeal. Submitted appeals must be received by the Program Administrator at admin@illinoisabp.com, by 11:59 pm CPT March 24, 2023. As the determination of appeals may influence a project's final score, and thus possibly the final selection of projects, all appeals must be reviewed by the Agency within a distinct timeframe. The Agency intends to have all submitted appeals determined by April 21, 2023, subject to the quantity and substance of appeals submitted.

This week, the Program Administrator found two distinct errors (impacting 10 applications) in the scores posted on March 10, 2023. The Approved Vendors with the impacted applications have been contacted and informed of these scoring errors.

An additional, full review of scores is underway to ensure no further errors exist in the published scores. The PA will publish updated scores after this audit is completed, if needed. There will be an allowance for additional appeals after that process concludes, if any additional errors are uncovered. As the two errors uncovered thus far decrease the scores of the impacted projects and thus do not have a negative impact upon other AVs, the deadline for appeal submission TODAY, March 24th will not change for AVs not impacted by errors in scoring. Those AVs who had a score change as a result of the errors have been notified of the change in scores and been given an additional two weeks to appeal their corrected scores.

- **REC Pricing Updates** The Agency is conducting two processes to update REC prices for the Illinois Shines Program and the Illinois Solar for All Program:
 - Proposed 2023-2024 REC Prices The first process is a refresh of inputs into the current REC pricing model to establish the REC prices for the 2023-2024 program year. The Agency issued a Request for Stakeholder Feedback on the proposed prices. Comments are due by March 24, 2023 and should be sent to IPA.ContactUs@illinois.gov.
 - O Update to REC Pricing Model & REC Prices for Subsequent Years This second process is a review of the REC pricing approaches for consideration of changes in methodology to be included in the next Long-Term Renewable Resources Procurement Plan ("LTRRPP"). The Agency has engaged Sustainable Energy Advantage ("SEA") to conduct that review. The report developed by SEA will be used by the Agency to develop the REC pricing methodology for the next LTRRPP. SEA released a written request for stakeholder feedback on March 7, 2023, with comments due on March 28, 2023. SEA hosted a public webinar for Illinois Shines and ILSFA stakeholders on Tuesday March 14, 2023 to discuss REC pricing policy issues, options, and implications. Ongoing Operations Updates

• Schedule B Generation and Availability via Approved Vendor SharePoint Folders

March REC invoicing is closed, and as the Program Administrator resumes verification of Part II applications,
Schedule Bs are being generated weekly and placed in Approved Vendor SharePoint folders. The Program



Administrator will send Approved Vendors an email for each project that is verified, to include confirmation of verification status and date. March 26, 2023 is the last valid Part II verification date for March to allow time to generate April REC invoices. Review of applications will continue throughout the last week of March, with Part II verification dates finalized in April.

Application Processing Updates

- The Program Administrator is now updating the application processing table at IllinoisABP.com/project-application-reports/ on Mondays, Wednesdays, and Fridays. On March 17, 2023, the PA released a detailed plan addressing the application backlog and remediation plans, and this week provides the following updates:
 - Weekly Special Announcements Beginning Monday, March 27, 2023, the PA will publish a weekly special announcement dedicated to application processing updates, our progress tracking, and any modifications to our processing plans to meet our commitments.
 - Clarification on date of "Reviewing Applications" An application submitted prior to the date shown in this column may still be in the verification process or in "Need Info" status. For example, an AV may have submitted an application and responded to and resolved any Need Info requests, but the Program Administrator may be reviewing data from multiple locations, performing or confirming calculations, or completing other activities necessary to verify the information in the application.
 - Need Info request delays The Program Administrator is currently addressing delays in the issuance of Need Info requests and thus processing of some applications. Our next special announcement on Application Processing will include revised processing and remediation plans.
 - o Application Processing Table Enhancements
 - The breakout of Part I and Part II applications by Group A and Group B within each project categories is in continued development.
 - By Monday, March 27, 2023, the application processing table will provide further clarification on the number of applications *Submitted, Reviewed*, in *Need Info* status, and *Verified* within each project category and application type.



• Community-Driven Community Solar Application Review and Scoring Process

Effective February 20, 2023, Community-Driven Community Solar entered the Scoring phase, which was expected to last for approximately three weeks, from February 20 - March 10, 2023; the scoring period is expected to extend for additional time, and the PA will continue to share updates as we move through the process.

Updates on Portal Issues, Improvements, and Future Releases

- With user support, the Program Administrator has continued utilizing a nightly, planned system maintenance window for the Program portal through March. For the week of March 27, 2023, the system maintenance window will shift to, and only include, Tuesday March 28 and Thursday March 30, from 8:00 p.m. to 10:00 p.m. CPT, both nights. During these maintenance windows, , the Portal is expected to be unavailable to users, which the PA and Agency hope will be minimally disruptive to Program participants. Any users working in the portal should save their work prior to the 8:00 p.m. CPT start of the system maintenance window each day, as any unsaved information will be lost when the system is moved into maintenance mode. In the event that portal restoration is unexpectedly incomplete as of 10:00 p.m. CPT on a given evening, an update notice will be sent to Approved Vendors and Designees.
- On Saturday March 25, 2023, a planned portal maintenance period will begin at 5:00 p.m. CPT, and is expected to last five hours, until 10:00 p.m. CPT. During this window, the portal is expected to be unavailable to users. Any users working in the portal should save their work prior to the 5:00 p.m. CPT start of the maintenance period. A notice of system restoration will posted to the Program website.

Requirements and Reminders

• Systems Out of Compliance for Failure to Deliver RECs - 90 Days to Comply

Per Section 6(a) of the <u>2019 REC Delivery Contract</u>, and 4.1(a) of the <u>2021 REC Delivery Contract</u>, all systems must be registered in either the GATS or M-RETS tracking registry. For systems larger than 5 kW, the first REC must be delivered within 90 days of the date the system is Energized/Part II verified. For systems equal to or less than 5 kW, the first REC must be delivered within 180 days of the date the system is Energized/Part II verified. According to Section 12(e) of the <u>2019 REC Delivery Contract</u>, and 2.3(e) of the <u>2021 REC Delivery Contract</u>, "Seller shall upload meter readings to PJM-EIS GATS or M-RETS at least annually prior to the registry cutoff to produce RECs for generation occurring in May as well as all previous months for which generation has not been recorded."

The PA has identified systems that are out of compliance with the REC contract for not delivering a REC and updating the tracking registry within one year of Part II verification. These systems have been communicated with AVs over SharePoint and/or email. Projects will be removed from the Program if they do not deliver a REC within 90 days of notice from the PA for failure to comply with requirements of the REC Contract. Deadline to comply is April 4, 2023.

- Minimum Equity Standard Compliance Plans and Waivers
 - On March 13, 2023, the Agency and Program Administrator held a webinar, Minimum Equity Standard (MES): Compliance Plan and Waiver Request Training, for stakeholders, in support of upcoming release of the Compliance Plan form in April, 2023 for the 2023-2024 Program Year. The webinar followed two earlier webinars held on the Equity Accountability System on October 4 and November 15, 2022, and included information on prior presentations, the MES Compliance Plan process and draft form, the Energy Workforce Equity Portal, and the Waiver Request Process. A recording of each webinar, the presentation slides, and relevant Q&A documents can be found at the Equity Accountability System page of the Program website, along with the final MES Waiver and the MAS Waiver Rationale document.
 - The Agency has released <u>updated forms for MES Waiver requests</u>. The <u>original MES waiver</u> was released last week on March 10, 2023 and has been updated to correct a few clerical errors. • EEC Block Capacity - Long-Term Plan Reopening

The Illinois Commerce Commission approved the request to re-open the 2022 Long-Term Plan in <u>Docket No. 22-0231</u>, and stakeholders are invited to interact with the docket in accordance with the ICC's rules of practice, with the following schedule in effect:

- Objections to the Agency's proposal Due February 2, 2023
- o Responses to objections Due February 16, 2023
- o Replies to responses Due March 2, 2023
- o Proposed Order Due March 16, 2023
- o Brief on Exceptions Due March 23, 2023
- o Reply to Briefs on Exceptions Due March 30, 2023
- With the docket open, the Agency will seek to provide an update on the question of dealing with applications submitted on November 1, 2022 in EEC Group A once the above schedule has concluded; the Program Administrator may hold Group B applications for ICC approval if it appears possible that Commission action may impact Group B capacity.

• 3G Cell Pack Switch Out

The IPA is aware that, as of about May 2022, inverters with communication modules using 3G cellular are no longer supported by internet service companies. These inverters will have to be upgraded with a 4G or 5G cellular module, Wi-Fi connection, or some other replacement communication protocol. If an inverter is not upgraded, the solar array's ability to auto-report production data will cease, or has already ceased. Since some customers may not be aware that an inverter for their array may stop auto-reporting production data, many AVs have been notifying affected customers and assisting with inverter updates where needed. As a reminder, AVs are responsible for entering system production in the tracking registry where the system is registered. If the process in upgrading inverters has posed an issue in production data reporting, please contact your sector strategist to explain the barrier and the steps being taken to resolve the issue.
