



# Reminder: Cure Annual Report Deficiencies by October 13, 2023, Group A Small DG Block Now Closed, Updated CDCS Timeline

# Program News

- Reminder: Final Date to cure Annual Report Deficiencies is October 13, 2023 Under all versions of the REC Contract, the last day to cure Annual Report discrepancies is October 13, 2023. It is crucial that AVs respond to any requests to cure outstanding discrepancies by October 13, 2023 to ensure alignment between Program Administrator, AV, and Contracting Utility records as the finalized data will be used for various contract compliance items, including Three-Year Rolling Average drawdown calculations. In the absence of confirmation from AVs on these items, Program Administrator records will be used. No cures can be made beyond October 13, 2023 and the data will be considered final after that date. The Program Administrator has distributed emails to AVs with discrepancies for the items listed below:
  - Collateral balance by Contracting Utility
  - RECs delivered by each system
  - o Energized systems that have not delivered a REC
  - Systems that are not yet Energized
  - o Community Solar subscriber data
- Distributed Generation Program News Recent DG Program updates include:
  - Group A Small Distributed Generation (DG) Block Soft Close Concludes; Waitlist in Effect As announced on October 4, 2023, the Group A Small DG soft close period concluded on October 3, 2023, and applications batched and submitted to the Program under Group A Small DG block after October 3, 2023 at 11:59 p.m. CPT have been placed on a <u>waitlist</u>. As a reminder, an announcement on Group A DG capacity availability was distributed on <u>September 6, 2023</u>. All projects submitted to Group A Small DG for the remainder of the Program Year will be waitlisted. New capacity for this category will be released next Program Year which commences on June 1, 2024.
  - DG Disclosure Form (DF) Application Programming Interface (API) Working Group Following the Working Group kickoff on September 18, 2023, further development based on the input provided at the kickoff meeting continues, and the second meeting of the Working Group will be scheduled soon. AVs and Designees interested in participating should email the Program Administrator at admin@IllinoisShines.com.
- New Disclosure Form CSV Template Available New CSV templates for Disclosure Forms have been updated to the Program portal, and are also available at the Program website's <u>Program Documents page</u>, in the Disclosure Forms sub-section. As a reminder, participating entities should always ensure they download the current version of the CSV template from the Program portal.
- Community Solar Program News Recent CS Program updates include:
  - Program Year 2023-24 Community Driven Community Solar (CDCS) The Program Administrator has completed the Application Review and Scoring Period for all 2023-24 CDCS applications ahead of the original schedule and Preliminary Scores were shared today, October 6. Preliminary Scores are not published on the Program website but are shared with individual AVs who submitted applications. AVs now have two weeks, until 11:59 p.m. CPT on October 23, 2023, to cure all scoring *Need Info* requests. ## **Ongoing Operations Updates**

• **Re-Batching for ICC Meetings** - In advance of each submission of batches to the ICC for approval, AVs are provided the opportunity to review the projects that are about to be submitted for re-batching. During rebatching, AVs have the opportunity to withhold or re-batch projects. In the absence of any action by an AV, the Program Administrator will re-batch the projects at their discretion and submit eligible projects to the ICC.

It is extremely important that AVs review their re-batching files on SharePoint to indicate any re-batching preferences, but especially requests to withhold projects from submission. The Program Administrator alerts AVs by email when they have projects that are eligible for re-batching and planned to be submitted to the ICC





in the next memo. Unfortunately, sometimes these communications are missed and projects are submitted to the ICC despite an AVs intent to hold a project back.

The Program Administrator requests that AVs who believe they may want to withhold or re-batch projects mark their calendars and review SharePoint folders for re-batching templates. This way, if any email alerts are missed, AVs are still aware of the dates that re-batching opens and can check if any projects are in the upcoming ICC submission. Below are re-batching windows for the rest of 2023:

#### **Application Processing Updates**

• Extended Part II Application Processing Times - The Program Administrator provides regular application progress updates on the Program website, including daily updates that began the week of September 18, 2023. In recent weeks, the Program Administrator has received an unusually high number of Small DG Part II applications. Due to these recurring high volumes week over week, Part II application review time is currently approximately three and a half weeks, exceeding the typical target of two-week processing. To address the queues and resume meeting the two-week processing target, the Program Administrator has shifted resources to add Part II capacity to the processing team. The Program Administrator continues to prioritize the review of applications based upon the submission date.

The Program Administrator is committed to restoring review times to the typical timeframes that AVs, Designees, and underlying customers expect. AVs and Designees are asked to remember that applications that are incomplete or contain discrepancies from Part I applications will take longer to process and will result in Need Info requests, which require complete and timely AV responses to verify the application. The Program Administrator is available to support AVs and Designees with application questions and appreciates the patience of stakeholders as we calibrate resources to meet application processing needs.

- Application Tips and Tricks Supplementing previous guidance, the Program Administrator seeks to continue supporting stakeholders in the avoidance of project applications entering *Need Info* status.
  - **System Expansion vs Co-Location** The Program Administrator recently sent some AVs emails requesting confirmation of system expansions. There is frequently confusion around the difference between an expansion and a co-location.
    - An **expansion** is when additional **capacity is added** to an existing system. The existing system can already be under REC contract in the Program, or it can be a system that was built outside of the Program, with just the expanded portion applied to the Program.
    - A **co-location** is when two or more systems are located on the same roof or the same parcel of land and **are owned by the same or affiliated parties**.





• As expansions and co-locations receive different REC pricing from general systems. For co-locations, AVs may be asked to provide proof that parties who own systems on the same roof or parcel (for example, two unaffiliated business that are located within and share the roof of a general office building) are unaffiliated, to ensure accurate REC pricing is applied to the project(s).

- Updates on Portal Issues, Improvements, and Future Releases The planned system maintenance windows on Tuesday and Thursday evenings (from 8:00 p.m. to 10:00 p.m. CPT) will extend through October. During these maintenance windows, the Portal is expected to be unavailable to users, which the Program Administrator and Agency hope will be minimally disruptive to Program participants. Any users working in the portal should save their work prior to the 8:00 p.m. CPT start of the system maintenance window each day, as any unsaved information will be lost when the system is moved into maintenance mode. In the event that portal restoration is unexpectedly incomplete as of 10:00 p.m. CPT on a given evening, an update notice will be sent to AVs and Designees. On October 12, 2023 the maintenance window will extend through 6:00 a.m. CPT on October 13, 2023 to accommodate additional releases.

- Long-Term Plan Update As announced on <u>August 15, 2023</u>, the Agency has released the draft 2024 Long-Term Plan for public review and comment. The Agency anticipates the next steps in this process with the following schedule:
  - September 29, 2023 Stakeholder comments due to IPA
  - October 20, 2023 Filing with ICC
  - February 19, 2024 ICC Order Expected
- October REC Invoicing REC invoices and Quarterly Netting Statements were made available for download from AV SharePoint folders on October 1, 2023. Invoices must be submitted to the utility by October 10, 2023 to receive payment for the October invoice period. Any invoice amounts not submitted to the utility by October 10, 2023 will be carried forward and included in the next invoice period (January 2023).
- Part II Verification Cut Off for October To allow time for invoice calculation and generation, the last valid Part II Verification date for October will be October 24, 2023. Applications that are Part II verified on or before October 24, 2023 will be included in the November invoicing period. Application processing will continue





throughout the last week of the month and any applications that are reviewed between October 25, 2023 and October 31, 2023 will be invoiced in December 2023.

- IPA Issues Request for AVs and Installer Designees Interested in Serving Stranded Illinois Shines DG Customers - As previously <u>announced</u>, the Program continues to review submissions on a rolling basis for entities interested in serving stranded customers, with particular interest in identifying AVs and/or installer Designees willing to assist stranded customers with project maintenance/repair work. Please see the full <u>Request for AVs and Designees</u>, including details regarding the opportunity to support stranded customers, eligibility requirements, and anticipated responsibilities.
- Program Administrator Office Hours Existing and prospective AVs and Designees who have Programmatic questions, project application inquiries, are experiencing technical difficulties with the Program portal, or seek support in resolving other challenges are invited to attend open Office Hours offered by the Program Administrator each week.
