

## Contracting Utility Registry Accounts

Illinois Shines requires that submitted projects include the initiation of an irrevocable standing order for its RECs to the applicable utility Buyer (Contracting Utility) in either GATS or M-RETS, which are REC tracking systems. This required information is verified during the Part II application review. The Contracting Utilities maintain various registry accounts to receive RECs, using distinct names and organized by the contract version projects used. Approved Vendors may review their executed REC Contracts or [Project Application Report #2](#) to confirm the Contracting Utility and contract version. When registering a system in GATs or M-RETS, the Approved Vendor must incorporate the Illinois Shines application ID into three fields: the *Name of the System* field, the *Unit* field, and the *Note* field.
