  - Additional Guidance on Certified Transcripts of Payroll ("CTPs")
    - Only CTPs that have been issued from the Illinois Department of Labor ("IDOL") are acceptable.
    - Please do not submit the following for CTPs. Submitting unnecessary documents will delay processing time.
      - IDOL applications/submission forms
      - United States Department of Labor ("USDOL") CTPs
    - There is no need to submit CTPs for weeks in which no work is performed. If these are included in a bulk file along with CTPs for weeks in which work is performed, that is permissible.
    - Please ensure the address on the CTP reflects the actual project location and is consistent with the address listed in the application.

- Forthcoming REC Contract Amendment The Agency is drafting a retroactive amendment that will apply to each REC Contract. All AVs with active REC Contracts will be expected to sign an Amendment for each of their active REC Contracts. The REC Contract amendment allows for implementation of several consumer protection initiatives, as well as extensions to the Annual Report submittal deadlines, which are governed by the REC Contract. The draft REC Contract amendment language is expected to be posted for stakeholder feedback in early December 2024, with all stakeholder comments due two weeks after posting. The final version of the REC Contract amendment is expected to be published by mid-January 2025. The REC Contract amendments are expected to be circulated for signatures from AVs in mid to late February.

Annual Report Update – The Program Administrator has finalized REC Performance Evaluations and CS
Parameters Evaluations to determine any Drawdown Payment amounts. Draft Drawdown reports will be
shared with AVs approximately the week of December 2, 2024. Additional details will be included in the
Drawdown email that is shared.

#### Timeline for Drawdowns and Related Events

- Approximately the week of December 2 Draft Drawdown Payment calculations made available to AVs on SharePoint for review.
- Approximately the week of January 6 Contracting utilities provide formal notification of the amount of Drawdown Payments to AVs.
- o 5 business days after notice date Deadline for AV to communicate if they prefer to make a cash payment or allowing the letter of credit used for collateral to be drawn upon (if applicable).
- 15 business days after notice date Utility will draw on collateral unless an alternative request was received from AV (see above) and/or payment was received by the 14th business day after notice date.
- o 90 days after drawn upon collateral AV required to top up collateral, if required.



The Agency intends to have all submitted appeals determined by <a href="mailto:becember 6">December 6</a>, 2024, subject to the quantity and substance of appeals submitted.

- Scores Published: AVs wishing to appeal their project score will have two weeks from the receipt of scores to submit an appeal to the Program Administrator. Appeals are due today, November 22, 2024 by 11:59 p.m. CPT.

# **Ongoing Operations Updates**

• Re-Batching for ICC Meetings – Due to an increase in late requests to withhold projects from submission to the ICC, the Program Administrator would like to remind AVs of the important information below.

In advance of each submission of batches to the ICC for approval, AVs are provided the opportunity to withhold or re-batch projects. AVs must indicate any requests to withdraw or withhold projects during the two-day re-batching window. In the absence of any action by an AV, the Program Administrator will re-batch the projects at their discretion and submit eligible projects to the ICC.

- It is extremely important that AVs review their re-batching files on SharePoint to indicate any re-batching preferences, but especially requests to withhold projects from submission. The Program Administrator alerts AVs by email when they have projects that are eligible for re-batching and planned to be submitted to the ICC in the next memo. Unfortunately, sometimes these communications are missed, and projects are submitted to the ICC despite an AVs intent to hold a project back.
- The Program Administrator requests that AVs who believe they may want to withhold or re-batch projects mark their calendars and review SharePoint folders for re-batching templates. This way, if any email alerts are missed, AVs are still aware of the dates that re-batching opens and can check if any projects are in the upcoming ICC submission. - December REC Invoicing Opens December 1, 2024 REC invoices and Quarterly Netting Statements will be
  made available for download from AV SharePoint folders on December 1, 2024. Invoices must be submitted
  to the utility by December 10, 2024 to receive payment for the November invoice period. Any invoice amounts
  not submitted to the utility by December 10, 2024 will be carried forward and included in the next invoice
  period (March 2024).
- Part II Verification Cut Off for December To allow time for invoice calculation and generation, the last valid
  Part II Verification date for December will be December 19, 2024. Applications that are Part II verified on or
  before December 19, 2024 will be included in the December invoicing period. Application processing will





continue throughout the last week of the month and any applications that are reviewed between December 20, 2024 and December 31, 2024 will be invoiced in February 2025.

- IPA Request for AVs and Installer Designees Interested To Serve Stranded Illinois Shines DG Customers As previously <u>announced</u>, the Program seeks entities interested in serving stranded customers, and <u>updates the lists</u> of participating vendors on a rolling basis. The original announcements include details regarding the opportunity to support stranded customers, eligibility requirements, and anticipated responsibilities.
- Designee Renewal Updated Due Date December 2, 2024 Designees and Nested Designees of the Program
  are required to renew their status annually, per Section 2.G of the Program Guidebook. In the 2024-25
  Program Year, Designee renewals are due on Monday, December 2, 2024 for all Designees and Nested
  Designees that registered in the program before June 1, 2024. See previous announcement for more details.
- 180-Day Prioritization Window for Public Schools Subcategories Updated Closure Date December 2, 2024

   As stated in the <a href="Program Guidebook">Program Guidebook</a> Section 1.E, Public Schools capacity is allocated by Group, tier, location, and project size subcategories. If any of the allocations are not filled within the first 180 days of the Program Year, Public School projects will be accepted on a first come, first serve basis regardless of Tier, EJC location, or project size. The 180-day prioritization window will close on Monday, December 2, 2024.
- Minimum Equity Standard (MES) Mid-Year Reports Due December 31, 2024 As announced on November 12, 2024, Mid-Year Reports to show progress toward meeting the MES for Program Year 2024-25 are due December 31, 2024. Participating AVs and Designees should submit their Mid-Year Report by completing the form found here. If your organization faces challenges in fulfilling these obligations, the Program Administrator is available to provide additional resources and guidance to help you reach compliance.
- Changes to Illinois Net Metering Bill Credits Update to Project Submission Deadline On October 10, 2024, the Agency noted the updated project submission deadline for ComEd and Ameren (from December 13 to December 31, 2024. For MidAmerican deadline remaining January 1, 2025) and updated the Frequently Asked Questions ("FAQs") document about Net Metering Bill Credit changes.
