What is a Designee?



Designee: Third party (i.e., non-Approved Vendor) entities that have direct interaction with end-use customers.

 Ex. installers, entities that perform maintenance and repair, marketing firms, community solar subscriber agents, lead generators, and sales organizations. All Designees are publicly listed on the <u>Find a</u>
Designee Report.



Nested Designee: Designees of Designees are called Nested Designees.

 Nested Designees may hold only Marketing/Sales Designee or Installer Designee roles. Only Approved Vendors can add Disclosure
Form Designees and Community Solar
Subscriber Agent Designees directly beneath their account.





Designee Types



Disclosure Form Designee: An entity that the Approved Vendor has designated who is permitted to generate Disclosure Forms on behalf of the Approved Vendor.



Community Solar Subscriber Agent Designee: An entity that the Approved Vendor has designated to manage the community solar subscription information for an Approved Vendor's Community Solar projects.



Marketing or Sales Designee: An entity that the Approved Vendor or Designee has designated to act as a marketing agent and/or customer acquisition agent on behalf of the Approved Vendor or Designee.



Installer Designee: An entity that the Approved Vendor or Designee has designated to install systems on behalf of the Approved Vendor or Designee.







How To Register as a Designee

- 1. Identify an Approved Vendor or Designee to work with and register as a Designee under them.
- A list of Approved Vendors and a list of Designees in the Program can be found on the <u>Find an Approved Vendor, Designee</u>, or <u>Subcontractor</u> webpage.

•	Disclosure Form Designee — An entity that is permitted to generate Disclosure Forms on behalf of an Approved Vendor. A Disclosure Form Designee may create disclosure forms only after it has established an affiliation in the port all in that risk with the Approved Vendor.
•	Community Solar Subscriber Designee — An entity that is permitted to manage the community solar subscription information for an Approved Vendor's community solar projects.
٠	Marketing or Sales Designee — An entity that is designated to act as a marketing agent and/or customer acquisition agent on behalf of the Approved Vendor or Designee. This includes, among others, entitles that ergage in solicitations through any channel (in preson, beliephone, etc.), as well as entitles that perform online lead generation.
٠	Installer Designee — An entity that the Approved Vendor or Designee has designated to install systems on the Approved Vendor's or Designee's behalf. All entities that install distributed generation facilities, with the exception of self- installers, must be conflicted by the limbs Commerce Commission pior to installing any distributed generation facilities in the State of Illinois, and must provide a Distributed Generation Installer certification during Designee registration and merewal.

Once a Designee has completed, and signed the Designee Request Form, it should be enabled to the Approved Verdor/Parel Designee to return to the Program started, it within the Approved Verdor/Parel Designee must provide approval to the Program Administrator to accept the Request Form. As got of the resistantial process, Designees must provide as Plantic Secretary of Sales Statement of Good distillated within the particular time of the Complete Complete Complete Statement (and the Complete Statement of Code) or one or more Approved Verdor/Parel Designees. A Designee is authorized to act only in that designated role with Approved Parelle Designees that have approved it as a Designee and have not revised that acceptance.

If the Designee ignores a suspension or termination decision made by the Program Administrator or the IPA and is its market activity nonetheless, any Aproved Vendor or Collegine, that works with the Designee during that priorid may est to discipline. Likewise, Approved Vendors and Designees found to be working with entities that fail to register as see with the Prozona will be subject to discipline.

How to Register as a Designee

3. Submit Registration Form to <u>admin@illinoisshines.com</u> with the following required items:

- Illinois Secretary of State Statement of Good Standing dated within the past 12 months.
- Minimum Equity Standard Compliance Plan or an Equity Eligible Contractor ("EEC") Application.
- Distributed Generation Installer Certificate with the Illinois Commerce Commission (If applicable).
 - Only required if you are registering as an Installer Designee.

Please Note: Form must be submitted by the Approved Vendor/Designee your company is registering under, authorizing the Program Administrator to process the request. Designees are not permitted to self-register.

Application Review and Approval

Illinois Shines Program Administrator team will intake and process the Designee registration request and will follow up as needed.

Application review typically takes two to four weeks.

- If items are not submitted, the review process may take longer.
- Once the application is processed, you will receive a confirmation email from admin@illinoisshines.com that you have been registered as a Designee.

Designee Renewal Requirements






Designee Renewal

Designees are required to renew their status in the Program annually.

Designees will submit a Designee Renewal Microsoft Form for that Program Year, and upload the following supplemental documents in their Designee SharePoint Folders:

- Illinois Secretary of State Statement of Good Standing dated within the past 12 months.
- Training materials and/or training certificates of completion showing that your agents and/or staff have been trained in accordance with Program requirements.
