- **New! Need Info Email Pause Due to Holiday** - The Program will not be sending *Need Info* emails on January 19, 2026, in observance of Martin Luther King Jr. Day. *Need Info* emails will resume on January 21, 2026.

- **Application Tips and Tricks** - The Program Administrator publishes [Tips and Tricks](#) to help support stakeholders avoid *Need Info* requests that delay application review and approval.
  - **Make sure to provide all relevant Certified Transcripts of Payroll (“CTPs”) for each contractor and subcontractor under contract for project construction activities.** Prevailing Wage is a minimum compensation level set by the Illinois Department of Labor (“IDOL”), by county, for construction activities related to public works. All Illinois Shines projects, with few exceptions, are subject to [Prevailing Wage](#). CTPs are the documentation required at the Part II application for Illinois Shines projects to demonstrate that Prevailing Wage was paid appropriately. The Illinois Shines program requires CTPs from IDOL. CTPs from the United States Department of Labor are not accepted unless the AV can prove the project is subject to the [Davis Bacon Act](#). No other documentation, including affidavits, is accepted for this requirement and should not be submitted.

- **New! 45-Day CDCS Application Window Opens January 16** - [As previously announced](#), as a result of the Modified 2024 Long-Term Plan, the Program will open an additional 45-day Community-Driven Community

Solar (“CDCS”) application window on January 16, 2026. The application submission deadline for the CDCS 45-day window is March 2, 2026, at 11:59 p.m. CPT. Applications are not accepted after the close of the 45-day window. Any project that is submitted during the 45-day application window and qualifies for the waitlist will be placed behind projects submitted during the initial 90-day application window, regardless of score. For the 90-day CDCS application window, final scores and random selection event results can be found on the Program [website](#).

- **New! New EAS Learning Series** - To highlight the importance of equity in the clean energy economy and within the Illinois Shines Program, the Program Administrator and the IPA DEI Team are launching the Illinois Shines Equity Accountability System (“EAS”) Learning Series. This series will offer virtual trainings and resources designed to support AVs and Designees in advancing equity focused best practices across their organizations. - **New! Part II Verification Cut Off for January** - The last Part II Verification date for January will be January 26, 2026. Applications that were Part II verified on or before January 26, 2026, will be included in the January invoicing period. Application processing will continue throughout the last week of the month and any applications that are reviewed between January 27 and January 31, 2026, will be invoiced in February 2026. Part II Verification Cut Off dates for each month have been added to the [Key Dates and Deadlines](#) page on the Program website.
- **New! Notice of Multi-Factor Authentication for SharePoint Users** - The Program Administrator will begin to require the use of a multi-factor authenticator (“MFA”) to access Illinois Shines SharePoint folders by all AVs and Designees, and other stakeholders, including utilities. Stakeholders will be notified when MFA access is applied to their folders, and the Program Administrator will be available to provide support. - **Annual Report Draft Drawdown Results** - The Program Administrator has performed the REC Performance Evaluation and Community Solar Parameters Evaluations following the close of the Annual Report Cure Period on October 30, 2025. These evaluations may result in collateral Drawdowns for system underperformance or failure to maintain Community Solar subscription rates. Evaluation results were provided to the utilities in mid-November, and the Program Administrator shared draft results with impacted AVs, via SharePoint, on December 16, 2025. Formal notice is expected to be provided by the contracting utility, the week of January 12, 2026.
- **Elective Pay Webinars’ Recordings Published** - [As previously announced](#), the IPA hosted webinars on Elective Pay on December 3, 2025, for municipalities, public school districts, nonprofits, and other tax-exempt organizations, and December 17, 2025, for AVs working with tax-exempt entities that have placed a clean energy project in service in the last year or so, or will soon do so. - **Portal Maintenance to Address Disclosure Form Visibility Issue** - [As previously announced](#), the Program Administrator became aware of an issue following a recent portal update release in which some DFs associated with one of an AV’s DF Designees may have been temporarily accessible to other DF Designees operating under the same AV via the Program Portal’s DF Report export functionality. The Program Administrator is developing a solution designed to fix the issue and has temporarily removed the DF Report export functionality from the portal until the fix is complete. The Program Administrator will be updating the portal to ensure appropriate DF access and expects to restore access and export functionality in the coming weeks. In the interim, AVs and Designees may request support directly from the Program Administrator if they require an exported DF report.

## Reference and Reminders

- **Re-Batching for ICC Meetings** - To avoid late requests to withhold projects from submission to the ICC, AVs must indicate any requests to withdraw or withhold projects during the two-day re-batching window. In the absence of any action by an AV, the Program Administrator will re-batch the projects at its discretion and submit eligible projects to the ICC. Please note that due to recent federal action, the Agency has temporarily paused enforcement of the two withhold limit from ICC meetings. This pause will be in effect until the Agency determines this pause is no longer necessary. AVs that do not wish to take advantage of these additional withholdings may send projects to the ICC during the re-batching window. Upcoming windows for re-batching are as follows:

- **Portal Maintenance and Releases** - Scheduled system maintenance occurs Tuesday and Thursday evenings, from 8:00 p.m. to 11:00 p.m. CPT, during which times the Portal is typically unavailable to users. Users working in the Portal should save their work prior to the 8:00 p.m. CPT start of system maintenance window. Any unsaved information will be lost when the system is moved into maintenance mode.
