## **July 14, 2023 Update**

The Program Administrator has revised the title, content, and structure of this Report (which was previously titled the “Disciplinary Action Report”). Previously, this Report contained only summaries of investigations that resulted in suspensions of entities participating in Illinois Shines. The Report now includes an additional section (“Warning Letters”) detailing all entities who received Warning Letters from the Program Administrator for confirmed Program violations since June 1, 2023. As required by the Consumer Protection Handbook, Warning Letters will be removed from this Report 12 months following their issue date.

As the Consumer Protection Handbook defines Warning Letters as non-disciplinary, we revised the title of the Report accordingly.

We also added a Table of Contents with links to each entry in the Report.

Finally, please note that not all violations of Program requirements are reflected in this Report. Only those that rise to the level of Warning Letters or Suspensions. Please see the Consumer Protection Handbook for further explanation of the processes followed by the Program Administrator for consumer protection violations and potential violations.
